

**INFORMAL MEETING OF EXPERTS FROM PARTICIPATING BSEC MEMBER
STATES TO THE PILOT PROJECT FOR INTRODUCTION OF THE BSEC PERMIT
FOR TRANSIT ROAD TRANSPORT AS OF
1 JANUARY 2010**

Istanbul, 17 December 2009

Conclusions

1. The informal meeting of the countries, which expressed their interest in fast track cooperation for implementing a pilot project on the issuing of the BSEC transit permit for trucks for the year 2010, was held at the BSEC Headquarters in Istanbul, on 17 December 2009.
2. The representatives of the Republic of Albania, Republic of Armenia, Romania, Republic of Serbia and Republic of Turkey took part in the meeting (The list of participants is attached as Annex I).
3. The participants considered and endorsed the draft Format and Usage Guidelines of the BSEC Permit as updated by the PERMIS according to the amendments proposed by the MFA of Romania in its Note 5308 dated 28 October 2009 and by the Republic of Serbia during the meeting and requested the PERMIS to print the pilot BSEC Permits and User Guides for each of the participating Member States (The corrected Format and Usage Guidelines of the BSEC Permit will be sent separately on 21 December 2009).
4. The interested parties agreed on a Timetable for the Implementation of the BSEC Permit (The Timetable for the Implementation of the BSEC Permit is attached as Annex II).
